- ☐ Name, SSN or ITIN, and date of birth
- ☐ USA Bank Name, Account and Routing number
- ☐ Foreign Bank Name and Address if value greater than \$10,000 USD - **FBAR**
- ☐ Identity Theft PIN (If applicable)

Dependents Information

- ☐ Name, SSN or ITIN, and date of birth for each child/dependent
- ☐ Custodial releasing child claim right to noncustodial parent - **Form 8332**
- ☐ Child care costs - **Provider's name/address/tax ID/amount paid**
- ☐ Educational Expenses - **Statement of Bursar Office and out of pockets expenses**

Income Source Documents

- ☐ Wages - Taxpayer and Spouse - **Form W-2**
